

## **Indian Institute of Corporate Affairs Rolls out industry centric 4 months Course “IICA’s Certified GST Consultant Program” for Employability Enhancement and Entrepreneurship Development.**

**GURGAON:** **Indian Institute of Corporate Affairs** is going to introduce industry-centric four (4) months “GST Consultant Program”, for the creation of a pool of **IICA’s Certified GST Consultants** with unique capabilities to deal with issues faced by MSMEs and other industries to ensure better services for low cost solution to customers as it is timely need of the dynamic economic environment of today.

The program will incorporate classroom training and online learning for the technical modules and mentored practical experience. It is divided into 3 levels, where the first level will deal with initial assessment comprising of the concept, Genesis, features and professional opportunities of GST, and a practical analysis of some key issues – mechanism of Input tax credit (ITC) followed by Valuation rules and procedures under GST & latest changes in GST : Returns, Refunds, Assessment, Appeals, Audit and Advance Rulings.

Level II will have a Continuous ongoing evaluation of 3-month internship wherein the candidates shall be evaluated and mentored by Experts on their problem solving and consultancy skills, that will enable the candidates to understand the practical aspects of the GST training and thereby helping them translate their learning into action with competence required to set up business in the area of GST Consultancy.

The final level III will be an advanced training program whereby participants will undergo training in the configuration of accounting systems with GST via 5 days online training. Post-training completion students must appear in 2-hour written examination on the 5th day of the training and will consist of multiple-choice type, 60 revolving questions.
